Dear Customer:

Welcome to Olympic View Water & Sewer District! The following is general information regarding the District, billing rates, and policies.

Olympic View Water & Sewer District, established in 1937, serves from the King/Snohomish County line north to 220th Street SW and west of Hwy 99 to the Puget Sound. The District serves approximately 4700 customers with municipal water and sewer.

A three-member Board of Commissioners elected by the residents of the District governs the District. The Commissioners appoint a General Manager. District Commissioners currently are:

Lora Petso, President Fanny Yee, Vice President John Elsasser, Secretary

Lynne Danielson is the General Manager of the District. The District staff consists of three office personnel and eight maintenance personnel. Our goal is to provide our customers with the best possible service, water quality that meets or exceeds all federal and state standards, and uninterrupted sewer service.

There is a \$5.00 fee to establish a new account. Routine billing is on a **bi-monthly** basis. Each bill is made up of three separate charges. The water portion contains a base rate of \$40.38 plus consumption. The step-rate for consumption is as follows:

A unit of water is equivalent to 748 gallons of water. Bi-monthly sewer service is \$78.10 for a single-family residence. Woodway sewer customers are charged an additional treatment differential fee of \$46.50.

Bills are mailed out on the first of the month and are given a discount of \$1.00 if payment is received in the office in 15 days. Bills are due upon receipt. A 10% late fee is assessed if not paid within the 45 days of the billing date. If the bill remains unpaid for 60 days, door hangers will be issued. Issuing door hangers will add an additional \$20.00 to the account. If payment is not received by the listed date service will be discontinued and the meter will be locked. There is an additional \$35.00 fee once the shut off order has been issued. Any checks returned by the bank for any reason are assessed a \$20.00 fee.
